32 The Northern Cheyenne Court convened on the 15th day of May, 2026 at 3:25 p.m. for a
33 Hearing to Show Cause on Motion's filed by both the Petitioner(s) and Respondent(s) of
34 this proceeding. Present at the Hearing was Legal Counsel for the Petitioner(s), Legal
35 Counsel for Jason Standing Elk, Waylon Rogers, Llevando "Cowboy" Fisher, Robert
36 Simpson, Lynwood Ewing, Sharlene Evans, Donovan Taylor, and Terrance Limpy, and
37 legal counsel for Rueben Roundstone, Corey Spotted Elk, and Josey "Wade" Red Hat.
38 The Court allowed each party to properly present their motion and argument to the Court
39 why they felt why their motion to for Contempt Should be Granted. Upon a showing of
40 good cause, the Petitioner(s) failed to show that they were in compliance with the

Restraints and Enjoinments on this proceeding by holding themselves out as Tribal Council members by making posts on Facebook and publishing an affidavit indicating that they are the, "Respectfully, your wrongfully displaced Tribal Council." Additionally, the Respondents, Jason Standing Elk, Waylon Rogers, Llevando "Cowboy" Fisher, Robert Simpson, Lynwood Ewing, Sharlene Evans, Donovan Taylor, and Terrance Limpy have all been argued to continue to be in violation of the Restraints and Enjoinments of these proceedings, by continuing to appear at the Little Wolf Capitol Building, reporting for work, publicly holding themselves out as members of the Tribal Council or any office of the Tribal Council. The order of this Court in paragraph 2 of the May 14, 2026 addendum indicates that all restraining and enjoinments from the April 30, 2025 Order will continue to be enforced. There is a consistent showing of both Petitioner(s) and several respondent(s) to disobey the Orders of this Court. It is for these specific reasons; this Northern Cheyenne Court makes the determination that continued disobedience of the Orders of this Court must be corrected.

From the foregoing, this Court enters this;

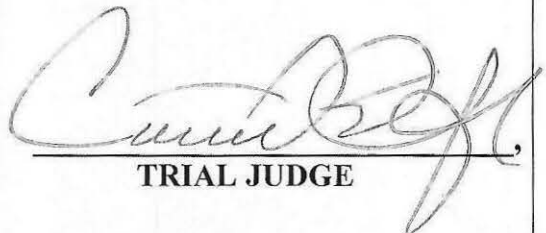
ORDER OF CONTEMPT & GAG ORDER

- 1. PETITIONER(S) AND THEIR LEGAL COUNSEL ARE HEREBY ORDERED TO BE HELD IN CONTEMPT, AND SHALL PAY A \$300.00 CONTEMPT FINE TO THE NORTHERN CHEYENNE COURT FOR FAILING TO COMPLY WITH THE ORDERS OF THIS COURT;**
- 2. RESPONDENT(S) JASON STANDING ELK, WAYLON ROGERS, LLEVANDO "COWBOY" FISHER, ROBERT SIMPSON, LYNWOOD EWING, SHARLENE EVANS, TERRANCE LIMPY, AND DONOVAN TAYLOR ARE HEREBY ORDERED TO BE HELD IN CONTEMPT, AND SHALL PAY A \$300.00 CONTEMPT FINE TO THE NORTHERN CHEYENNE COURT FOR FAILING TO COMPLY WITH THE ORDERS OF THIS COURT;**
- 3. THE MAY 20, 2026 HEARING IS HEREBY VACATED AND WILL BE RESET BY ORDER OF THIS COURT, UPON ALL CONTEMPT FINES BEING PAID IN FULL TO THE NORTHERN CHEYENNE COURT, WITH THE EXCEPTION OF THE MAY 18, 2026 4:00 P.M. DEADLINE;**
